This PhD thesis explores these cross-border dimensions by identifying a number of pressing questions and providing insight into the interests that are at stake in such situations. The book investigates what (if any) standard-setting is in place in three national jurisdictions (Ireland, Germany, and the Netherlands), as well as in the relevant European jurisdictions (EU law and the European Convention on Human Rights). The analysis provides insight into what considerations and interests have played a role in legislative debates and case law, in what respects the regimes differ, and how European law has influenced national standards. Additionally, the book looks at how the relevant jurisdictions respond to cross-border movement in these areas and how they interact. Thesis.
